CAMPING MUNICIPAL OF NOTRE DAME DE MONTS GENERAL RENTAL CONDITIONS FOR A LOCATION

The information collected on this form is recorded in a computerized file by the municipal campsite for reservations. They are kept for a period of 10 years and are intended for internal use by authorized persons of the campsite management.

In accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, you can exercise your right of access and portability to data concerning you, to have them rectified, to have them deleted by contacting preferably by electronic means in or by post by writing to Mairie 4 rue de la Barre 85690 Notre Dame de Monts.

By submitting this form, I agree that the information entered will be used, used and processed for my stays on the campsite.

In order to provide the most appropriate or desired pitch to the customers upon their arrival, the Orgatte campsite accepts pitch rental bookings.

They are subject to the following General Conditions:

- The Rental is valid upon receipt of the Rental Contract form, fulfilled and signed by the customer, with attached payment of 61Euros, comprising of 50€ for deposit and 11€ for running cost. The form shall be accepted and signed by camping management and then returned to the Customer.
- It is Camping Management decision to accept or reject the rental application.
- The day before departure on site, the Customer shall proceed to the full payment of the pitch rental (61€ deposit and running cost to be deducted). The payment shall be based upon the declared number of occupants and duration of the stay according to the rental booking form. Long stays can be paid on a monthly basis.
- Payment are to be made by Bank Check (Euros currency only), cash (Euros), credit card, travellers checks, and bank transfer or wire transfer(refer to Campsite IBAN code).
- The rental is against the Customer Name; no sub rental to a third party is allowed, nor leaving the pitch to others. Only one caravan or only one camper (van) per pitch. No more than two vehicles per location.
- The booked pitch will be available for the Customer from 14pm at arrival, and shall be left/cleared before 12am the day of departure. One extra night cost shall be charged in case of late leaving (after 12am)
- The pitch "Accueil vélo" one persons are subject to accommodate another person on the same location and for a maximum of three nights.
- Any Rental / Contract modification must be reported to Campsite Management.
- The reservation will be final after payment of the deposit and return of the completed and signed contract. In case of cancellation of the stay, and for whatever reason, no refund of the deposit and administrative costs will be made and in accordance with the legal provisions on force.
- In case of late or delayed arrival and in order to keep the booked pitch available, the Customer shall advise the camping management of their intent. Camping Manager reserves the right to release the booked pitch to another party if after 24 hours of the scheduled arrival time there is no information from the Customer.
- In compliance with article 211-1 of the 'code rural', and with by-laws and ministerial decrees of implementation, Category 1 dogs (pit-bulls) are forbidden, Category 2 dogs "used for guarding and protection" (Rottweiler, etc.) must be muzzled and held on a lead by an adult (article 211-5 of the 'Code rural'. Upon arrival at the campsite, the identity documents and anti-rabies vaccination certificates of cats and dogs must be presented. All cats and dogs must wear collars. In the absence of their owners, who remain legally responsible for them, dogs or other animals should neither be allowed to wander freely on the campsite, nor be left shut in on the campsite
- For all campers' welfare, the camping staff is vigilant regarding to health and safety, cleanliness and aesthetics of the campsite and facilities. Thank you not to throw cigarettes butts, papers, rubbish, and pick up the excreta of your pet.
- Occupants are required to abide by the site and the neighbourhood. Silence is imperatively required between 11pm and 7am.
- The tenant must ensure that his contract of insurance covers his civil liability in case of: damage; Of the property of others (dwelling, forest, crops.....)
- The Campsite is not responsible for theft, fire, inclement weather, or various events under responsibility of the camper.
- In case of dispute/ litigation not settled by mutual agreement, only the Administrative Court of Nantes (44, France) will be the competent jurisdiction.
